

2023 GRAND VALLEY POWER <u>WESTERN COLORADO COMMUNITY COLLEGE ELECTRIC</u> <u>LINEWORKER SCHOLARSHIP</u>

Grand Valley Power's Western Colorado Community College Electric Lineman Scholarship is created to support students pursuing an Electric Lineworker certificate from Western Colorado Community College.

While this scholarship is open to any applicant that lives in Mesa County; priority will be given to applicants who reside in households served by Grand Valley Power.

ELIGIBILITY REQUIREMENTS

Applicants must:

- Submit all the required information on the application,
- Have a letter of acceptance from Western Colorado Community College in the Electric Lineworker program,
- Enroll full-time (min. 12 credit hours per semester or quarter),
- Currently reside in Mesa County at the time of application.

SELECTION CRITERIA

Applications must be made on forms supplied by Grand Valley Power and must include:

- 1. Official transcript from the last high school or college attended.
- 2. Two letters of recommendation from non-relatives.
- 3. A written essay on why the applicant should be awarded a Grand Valley Power Electric Lineworker Scholarship. The applicant should describe the chosen career path you are taking and why. The applicant should also discuss such items as school and community involvement, volunteer experience, leadership and work opportunities and financial need.

Scholarship recipients will be required to provide photograph suitable for press releases and will be required to execute a release form authorizing its publication.

Applications must be postmarked or submitted online at gvp.org by June 1, 2023. Applications being mailed should be sent to; Grand Valley Power, Re: WCCC Electric Lineworker Scholarship, 845 22 Road, Grand Junction, Colorado 81505.



AWARDS

One (1) \$2,000 scholarship will be granted to a student in 2023.

Awards may be used to cover any of the following costs at Western Colorado Community College:

- * Tuition costs.
- * On-campus room and board expenses during the academic year only.
- * Appropriate allowances for books and fees.

The Grand Valley Power Electric Lineworker Scholarship may be combined with other scholarships, grants and awards.

This scholarship is not renewable. Applicants can only receive one GVP scholarship per lifetime. Applicants are not eligible to receive multiple scholarships awarded by Grand Valley Power. Priority will be given to applicants who live in a home that receives electricity from Grand Valley Power.

A committee of electric lineworkers appointed by the management of Grand Valley Power will review all applications received by the due date and select the scholarship recipient, who will be notified by mail by July 1, 2023.

All decisions by Grand Valley Power are final.


